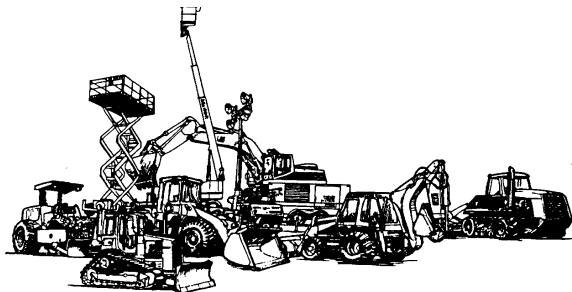

The two-day event will be at Holly Gray Park located near Flatwoods, WV.

The Show will feature a broad range of forestry, logging and sawmill equipment displays and demonstrations, along with educational exhibits, World Class Lumberjack competition, Professional Logger Competitions, horse skidding demonstrations, souvenirs, youth contests, heritage crafts, chain saw carving, and entertainment for the entire family.
